- Performance Show June 17<sup>th</sup>
  - o Already have entries coming in online
    - Online registration gives waived office fee
    - Deadline is noon on June 16<sup>th</sup>
- Weekend Show
  - o \$25 Clinic Fee/ Show fees will be same/ Office Fee waived if preregistered
  - o Camping 4-H will get charged only for hook-ups only
    - Open charged for camping
  - o Stalls are free for 4-H'ers as well
    - Parks asked that we give them a general number of people wanting to use stalls
    - HC can keep the open stall monies if the kids want to clean the stalls under Park's stipulations
  - o Refer all open people to Parks to pay that way
    - "Non-4-H Riders must contact Ryan with Parks @..."
    - Possibly advertise that camping and stalling are available and contact parks
  - o Motion to scrap camping/stalling (Mike/Holly) Passed.
    - Can still contact Parks if need either of these, but will not be included in our advertising

## Fair – Kelly

- Test July 15<sup>th</sup>
  - o 8AM & 10AM test times in Al Lesser

- Patterns Lyndsay is taking care of choosing these
- Levels testing
  - o Let all new members who are W/T & Level I that they can test any Monday or Wednesday (with the exception of Ranch Horse – unless a lesson day)
    - June 12<sup>th</sup> & 26<sup>th</sup> are only two Ranch Horse testing opportunities
  - June 30<sup>th</sup> is deadline
    - W/T do not have to take a written, but all other levels do
    - All levels must pass both written and riding tests to level up
    - There is a showmanship only test out there
  - o Lori recommended setting up levels testings in the fall as well
  - Rules and verbiage of leveling up for Grand and Res High Pts
    - If they fail the levels test to the next level, they miss out on Grand and Res for the next season
    - It is recommended that this rule is re-evaluated
    - Premium book is already out, but it is definitely something our committee should review
    - One point to be made is that our committee does a phenomenal job of educating the kids
    - This year, we've had out of county raters come in and say our kids aren't ready
      - This is a great thing. It shows us our holes that we need to address to keep these kids safe and moving forward
    - We've also added a lot of testing opportunities as well
  - o Fair entries due June 30<sup>th</sup>
  - o Livestock interviews in Bennett July 11<sup>th</sup> 4-6:30PM and Tuesday, July 18<sup>th</sup> 4-7PM and Thursday, July 20<sup>th</sup> both in Rendezvous Rooms
